

## DMV Fee Increases As of September 1, 2009

*enacted by the 2009 Florida Legislature*

The below fees are the State fees associated with each transaction. It does not include the local service fee for the Tax Collector's Office which varies per transaction and will not increase from the current rate. All of the fee increases are going back to the State's General Revenue Fund and will not stay locally.

The fee increases were enacted by the 2009 Florida Legislator and approved by Governor Charlie Crist. Any questions regarding the fee increases should be addressed to your legislator's office.
