IMPORTANT DATES

Your Birthday:

Renewal of motor vehicle license plate, which expires midnight of the owner's birthday. Renewals are accepted 90 Days prior to birth month. This applies to passenger cars, recreational vehicles, light trucks under 5,000 lbs., small trailers and motorcycles. Vessels also expire on the owner's birthday.

• January:

Receive 2% discount on payment of real estate and tangible personal property taxes.

• February:

Receive 1% discount on payment of real estate and tangible personal property taxes.

• March:

Full amount due on property taxes by March 31st.

• April:

All unpaid real estate property taxes become delinquent April 1st. At this time a 3% interest charge is added to the gross amount. Delinquent real estate property taxes will be advertised in a local newspaper and the cost of advertising will be added to the delinquent bill.

All unpaid tangible personal property taxes become delinquent April 1st. At this time a 1.5% per month interest charge is added to the gross amount. Within 45 days delinquent tangible personal property taxes will be advertised in a local newspaper and the cost of advertising will be added to the delinquent bill.

New Local Business Tax Receipts are prorated beginning April 1st; half-year fees apply.

Applications for next year's property tax installment payment plan due April 30th.

• May:

List of delinquent personal property taxes advertised in a local newspaper one time.

List of delinquent real estate taxes advertised once per week for three consecutive weeks, prior to tax certificate sale, in a local newspaper.

• **June:**

Tax warrant processing begins on delinquent tangible personal property taxes June 1st.

First Property tax installment plan payment due on or before June 30th.

• **July:**

First installment must be received by July 31st, discount not applicable and 5% penalty is added. If not received participation in the program is canceled.

Local Business Tax Receipt renewals begin July 1st.

• **August**

N/A

• **September**

September Local Business Tax Receipt renewals due by September 30th.

Second property tax installment program payment due by September 30th.

• **October:**

Local Business Tax Receipts become delinquent October 1st, and late fee applies.

• **November:**

Collection of real estate property taxes and tangible personal property taxes begins. Receive a 4% discount on payments made by November 30th.

• **December:**

Receive a 3% discount on payment of real estate and tangible personal property taxes.

Third party tax installment program payment due December 31st.

Registration and renewal of trucks over 5,000 pounds, truck tractors, semi-trailers, buses or vans carrying ninepassengers or more for hire, due by December 31st. Mobile home decals also expire December 31st.
